




Conclusiones

- Es importante avanzar en la planeación del segundo dividendo digital
- México trabaja en la liberación de la banda de 614 – 698 MHz (canales 38 al 51 de TDT) para antes del final del 2018
- La región de Norteamérica logrará liberar la banda de 600 MHz antes del 2020
- Es importante armonizar lo más posible el espectro liberado en la región para garantizar interoperabilidad y economías de escala
- Sí es posible asignar más espectro para servicios de TDT en la banda de UHF al tiempo de liberar el espectro de la banda de 600 MHz para servicios IMT
