Me permito presentar el informe de mi participación en representación del Instituto y en calidad de panelista en el 17º Simposio Mundial para Organismos Reguladores (GSR-17), organizado por la Unión Internacional de Telecomunicaciones (UIT) en colaboración con el Gobierno de Bahamas, llevado a cabo en Nassau, Bahamas, del 11 al 14 de julio de 2017.

El GSR es un evento anual que desde el año 2000 reúne a las autoridades de los organismos nacionales de regulación de telecomunicaciones y de las tecnologías de la información y la comunicación (TICs), y en general a los Miembros del Sector de Desarrollo de las Telecomunicaciones de la UIT (UIT-D), para intercambiar puntos de vista, experiencias y mejores prácticas regulatorias y de política pública respecto a temas relevantes de este sector.

Previo a las sesiones formales del GSR se llevó a cabo el "Global Dialogue on Digital Financial Inclusion: The Security of Digital Financial Services", en el que se abordaron temas relativos a:

- Tecnologías que protegen las transacciones electrónicas.
- Simulación y resolución de ataques cibernéticos.
- Responsabilidad colectiva para asegurar la fiabilidad, seguridad y confianza de los servicios financieros digitales.

Por su parte el GSR abarcó temas relacionados con:

- Inteligencia artificial, realidad virtual, algoritmos y robots como impulsores de la transformación digital.
- Regulación colaborativa en un ecosistema digital.
- Fiabilidad de redes y dispositivos para servicios digitales.
- Acceso asequible a las TICs en una economía colaborativa.
- Itinerancia en el mundo digital.


