Me permito presentar el informe de mi participación del 9 al 20 de noviembre en representación del Instituto y en calidad de Jefe Alterno de la Delegación Mexicana, en la Conferencia Mundial de Radiocomunicaciones 2019 (CMR-19) de la Unión Internacional de Telecomunicaciones (UIT) que se llevó a cabo del 28 de octubre al 22 de noviembre de 2019, en Sharm el-Sheikh, Egipto; así como en representación del Instituto y en calidad de Vicepresidente en la 80ª Reunión del Comité de Políticas de la Economía Digital (CDEP) de la Organización para la Cooperación y el Desarrollo Económicos (OCDE) que se realizó los días 21 y 22 de noviembre del año en curso, en París, Francia.

**Conferencia Mundial de Radiocomunicaciones 2019 (CMR-19) de la Unión Internacional de Telecomunicaciones (UIT)**

Las conferencias mundiales de radiocomunicaciones (CMR) se celebran cada tres o cuatro años y su labor consiste en examinar y, en caso necesario, modificar el Reglamento de Radiocomunicaciones, que es el tratado internacional por el cual se rige la utilización del espectro de frecuencias radioeléctricas y de las órbitas de los satélites geoestacionarios y no geoestacionarios. Las modificaciones se realizan sobre la base de un orden del día determinado por el Consejo de la UIT, que tiene en cuenta las recomendaciones formuladas por las conferencias mundiales de radiocomunicaciones anteriores.

De conformidad con la Constitución de la UIT, la CMR puede:

- Revisar el Reglamento de Radiocomunicaciones y cualquiera de los Planes correspondientes de Asignación y Adjudicación de Frecuencias;
- Examinar cualquier asunto de radiocomunicaciones de carácter mundial;
- Formular instrucciones dirigidas a la Junta del Reglamento de Radiocomunicaciones y a la Oficina de Radiocomunicaciones, y revisar sus actividades;

el crecimiento de una economía digital accesible, innovadora, abierta, inclusiva y confiable para alcanzar prosperidad sostenida y bienestar social.

El CDEP igualmente busca ser una plataforma para el intercambio de buenas prácticas para aprovechar el potencial de las Tecnologías de la Información y la Comunicación (TIC's), en especial del Internet, y de la digitalización para lograr objetivos socioeconómicos claves para la mejora de la calidad de vida en general.

Durante esta reunión, el Comité llevó a cabo la designación de su Presidente y Vicepresidentes para el año 2020, permitiéndome fungir por segundo año consecutivo como Vicepresidente del mismo.

Dicha designación quedó de la siguiente manera:

Durante la reunión del CDEP se presentó una actualización sobre la implementación del proyecto *Going Digital*, en su fase II y se discutieron aspectos relativos a la Inteligencia Artificial (AI), en donde se expuso el trabajo del Observatorio de Políticas de AI, así como el funcionamiento de la red informal de expertos en AI de la OCDE.

En el marco de las reuniones del CDEP y sus grupos de trabajo, se llevó a cabo una reunión con Vitor Elísio Menezes, Secretario de Telecomunicaciones y Daniel Brandao Cavalcanti, Coordinador General de Agenda Digital del Ministerio de Ciencia, Tecnología, Innovación y Comunicaciones de Brasil, así como con Taís Niffenegger, Jefe de Asesoría Internacional y Víctor Muniz Estevam Dias, Asesor Internacional de Agencia nacional de Telecomunicaciones (ANATEL), a fin de intercambiar experiencias sobre decisiones regulatorias y de política pública recientes.

Durante la discusión del punto 10.c. de la agenda de la reunión referente a plataformas en línea, en la que participó el Comité de Competencia de la OCDE, el Instituto señaló la importancia del trabajo horizontal entre los diversos comités de la OCDE toda vez que, en una reciente evaluación de competencia realizada durante este año 2019, se considera que no se tomaron en cuenta trabajos previos encabezados por el CDEP, concretamente el OECD Telecommunication and Broadcasting Review of Mexico 2017.
